Dear Elmbrook Families:

Thank you to the 1,222 parents and guardians who participated in the 2016 Satisfaction Survey.

Respondents were asked to evaluate the work of District Leadership, as well as provide input on schools they were connected to. Responses to District prompts include:

- **91% of respondents are satisfied** with the School District of Elmbrook.
- 88% of respondents agree that the Board of Education and Superintendent make decisions aligned to the mission of the School District.
- 84% of respondents agree that the Board of Education and Superintendent are effectively improving the District.
- 83% of respondents feel the District keeps families informed of issues that are important.

While a new scoring method was utilized this year (scale of 4) to more accurately reflect the school staff, student and parent survey responses, the District's approach to identify domain strengths and opportunities for improvement continues. Analysis of the *School-Based Parent Survey Responses* suggests the following:

- **Overall Quality** (3.3), **School Safety** (3.4) and **Teacher and Administrator Responsiveness** (3.4) domains continue to be strong and are valued by our parent community.
- The **Teaching and Learning** domain (3.1) and, in particular, our ability to meet the needs of every student, was identified as a District strength and yet remains a challenge to our staff to continue work towards making learning personal for all students.
- The **Homework and Reporting** domain (3.1) continues to be an opportunity for growth as our engaged parent community seeks the current and best information about their child's progress and performance.

The School District of Elmbrook values the feedback and uses the results to:

1. Inform the annual School Improvement planning process, which develops action plans and accountability measures that are monitored and reported throughout the year.
2. Guide performance feedback - results from all student, parent and staff surveys are reported to the Board of Education and used throughout the evaluation process.

3. Celebrate success – historically our stakeholders take great pride in our district and that is reflected throughout the survey results. Collecting feedback annually validates the direction of the district, as well as guides improvement efforts.
